Covernment circles assert that inc assets of the Union Banking Corporation and its subsidiaries were frozen because capital and control came from a Netherlands institution called the Bank Voor Handel en Scheepvaart (Bank for Trade and Shipping)) in Rotterdam, one of the Thyssen string of banking houses on the continent. It was subject to the freezing order, however, as a Dutch corporation, and not as a German-owned property.

As the custodian of all Dutch property outside the Netherlands, the Netherlands government in exile represents that it, too, would seem to have some rights in the matter. Nevertheless all of Thyssen's properties were confiscated by the Nazi regime back in 1939, and thus it might appear that the assets here are legally a part of the German government's assets in the United States.
